#### **Emissions Trading Scheme**

Department for Energy Security and Net Zero (DESNZ) are keen to discuss some of the concerns local authorities highlighted in their response to government's consultation on extending the Emissions Trading Scheme to include waste incinerators, and what that might do to the viability of heat networks, new or existing. ## Warm Homes Retrofit Funding

Government has confirmed allocations to councils of the <u>local grant</u> and <u>Social Housing Fund 3</u> for warm homes. There are several reforms to the grants which are positive, moving towards our asks for funding certainty, flexibility, and support for place-based approaches to retrofit. Trailblazer devolution areas will include retrofit funding within integrated settlements. The LGA is engaging with

Government as it develops its Warm Homes Plan, we hope to see further reforms enabling place-based approaches to retrofit.

#### Regional Energy Strategic Planning (RESP) forums

The National Energy System Operator (NESO) is commencing their first ever RESP forums. These online forums are intended for organisations, businesses, and individuals with a keen interest in the energy system in your area. #### Heat networks and the energy ombudsman

From 1 April 2025, new legislation will mean that all heat network consumers will have access to Energy Ombudsman for alternative dispute resolution. To ensure a smooth transition, Energy Ombudsman is urging all heat network suppliers to register with them as the new legislation comes into effect. Find out more on the Ombudsman website.
